<b>Deaf/Hard of Hearing</b>	A report from one or more of the following: <ul style="list-style-type: none"> <li>• An audiogram from a professionally qualified Audiologist and/or ENT Consultant, indicating moderate to profound bilateral hearing loss (i.e. above 40dB)</li> <li>• A letter from the principal from a school for the Deaf confirming attendance</li> </ul>	No age limit
<b>Developmental Co-ordination Disorder (Dyspraxia/Dysgraphia)</b>	A report from a <ul style="list-style-type: none"> <li>• Psychologist</li> </ul> OR <ul style="list-style-type: none"> <li>• Occupational Therapist</li> </ul> OR <ul style="list-style-type: none"> <li>• Neurologist diagnosing Developmental Co-ordination Disorder (Dyspraxia)</li> </ul>	No age limit

<b>Physical/mobility</b>	<p>A report from an</p> <ul style="list-style-type: none"> <li>• Orthopaedic Consultant</li> </ul> <p>OR</p> <ul style="list-style-type: none"> <li>• other relevant specialist diagnosing a significant physical or mobility difficulty.</li> </ul>	No age limit
